



Minor Participant Waiver, Release, Indemnification of All Claims & Covenant Not to Sue

NOTICE: THIS IS A LEGALLY BINDING AGREEMENT. Read this document carefully and in its entirety. By signing this agreement, you give up your right and the right of the minor named below to bring a court action to recover compensation or obtain any other remedy for any personal injury or property damage however caused arising out of the named minor's participation in Moon Parks and Recreation programs, now or at any time in the future.

Acknowledgment of Risk

I, in my legal capacity as the parent/guardian of the minor named below, do hereby acknowledge and agree that participation in Moon Parks and Recreation activities comes with inherent risks. I have full knowledge and understanding of the inherent risks associated with participation in Moon Parks and Recreation activities, including but in no way limited to: (1) slips, trips, and falls, (2) aquatic injuries, (3) athletic injuries, and (4) illness, including exposure to and infection with viruses or bacteria. I further acknowledge that the preceding list is not inclusive of all possible risks associated with participation in Moon Parks and Recreation programs and activities and that said list in no way limits the operation of this Agreement/Waiver.

COVID-19 Warning & Disclaimer

COVID-19 is an **extremely contagious** virus that spreads easily through person-to-person contact. Waiver, Release, Indemnification & Covenant Not to Sue

In consideration of the participation of the minor named below in Moon Parks and Recreation programs, I, in my legal capacity as the parent/guardian of the minor named below, affirm that I am at least eighteen (18) years of age and on behalf of myself and the minor named below, our heirs, representatives, executors, administrators, and assigns, AGREE TO HEREBY RELEASE Moon Parks and Recreation, its appointed officials, directors, members, employees, agents, successors, grantees, assigns, representatives and insurers, as well as the Township of Moon, its elected and appointed officials, employees, agents, successors, grantees, assigns, representatives and insurers (hereby altogether the "Releasees") from all suits, causes of action, claims, charges, losses, or demands of any nature whatsoever including, but in no way limited to, claims of negligence, which I, on behalf of myself and the minor named below, our heirs, representatives, executors, administrators and assigns may have, now or in the future, against the Releasees on account of personal injury, property damage, death or accident of any kind, arising out of or in any way related to the use of

Moon Parks and Recreation facilities/equipment or participation in Moon Parks and Recreation programs whether that participation is supervised or unsupervised, however the injury or damage occurs, including, but not limited to the negligence of Releasees.

In consideration of the named minor's participation in Moon Parks and Recreation programs, I, the undersigned parent/guardian of the minor named below, on behalf of myself and the minor named below, our heirs, assigns, representatives, family members, estates, and next of kin agree to INDEMNIFY AND HOLD HARMLESS the Releasees from any and all causes of action, claims, demands, losses, or costs of any nature whatsoever arising out of or in any way related to our participation in Moon Parks and Recreation programs and activities. I, for myself and the named minor, willingly assume any risks associated with our presence and participation and accept that there are also risks that may arise due to other participants, which I also willingly assume.

I agree that the named minor and I shall comply with all stated and customary terms, posted safety signs, rules, and verbal instructions from Moon Parks and Recreation's staff and that our presence and participation in any activities and/or programs of any nature of Moon Parks and Recreation is conditional upon such compliance. I further consent to Moon Parks and Recreation's staff taking my or the named minor's temperature, and I acknowledge that the named minor below and I may be denied access to or be forced to vacate Moon Parks and Recreation programs if either of us evidence any symptoms of sickness or illness, including, without limitation, symptoms of exposure to bacteria, fungus, viruses, unknown contagious diseases, or COVID-19.

I hereby certify on behalf of myself and the minor named below that I have full knowledge of the nature and extent of the risks inherent in participation in Moon Parks and Recreation programs and that I, on behalf of myself and the named minor, am voluntarily assuming said risks. I understand that I and the named minor will be solely responsible for any loss or damage, including personal injury, property damage, or death, that the named minor sustains while participating in Moon Parks and Recreation programs and that by signing this agreement I, on behalf of myself and named minor, HEREBY RELEASE the Releasees from all liability for such loss, damage, or death. I further certify that the minor named below is in good health and has no conditions or impairments which would preclude his/her safe participation in Moon Parks and Recreation programs.

The invalidity or unenforceability of any provision of this Waiver shall not affect the validity or enforceability of any other provision of this Waiver and Release, which shall continue in full force and effect.

By signing this Waiver, I acknowledge that I am voluntarily giving up legal rights and that if anyone is hurt or property damaged during our presence or participation in any Moon Parks and Recreation programs, I may be found by a court or arbitrator to have waived my right to maintain a lawsuit or pursue damages on my own behalf and on behalf of the minor named below against the Releasees for any claim from which I have released them in this Waiver.

I further certify that I am of lawful age (18 years old or older) and otherwise legally competent to sign this agreement, and that I have legal capacity to act as the parent/guardian of the named minor below. I further understand that the terms of this Waiver and Release are legally binding and I hereby certify that I am signing this agreement, after having carefully read it, of my own free will.
